

## Privacy Policy Agreement (cookies) Universal S.A.

Confidentiality and security of your data is important for Universal S.A. This agreement of Cookies privacy policy provides information on the personal data collected by cookies, governed by the EU Directive "e-Privacy" of 26 May 2012, and Law no. 506 of 17 November 2004 concerning the processing of personal data and privacy in electronic communications.

In order to comply with the legislation in this field, all website users are required consent before transmitting the cookies on their computers when accessing this site. By "User" we understand any one (person or legal entity) accessing [www.universalsa.ro](http://www.universalsa.ro), which will be referred to as the "site", regardless of the page or resource it visits to the site or the action it wants to undertake through the pages.

An "Internet cookie" (also known as "Cookie Browser" or "HTTP cookie" or simply "cookie") is a small file, consisting of letters and numbers, which will be stored on your computer, mobile terminal, or other equipment of a user who is accessing the site. The cookie is installed by request issued by a web server to a browser (eg Internet Explorer, Chrome) and is completely "passive" (does not contain software viruses or spyware and can not access information on a user's device).

A cookie consists of 2 parts: the name and content or cookie value.

Life of a cookie is determinated. Technically speaking only the web server that sent the cookie can access it again when a user returns on the website associated with the respectively webserver. The user does not need a user account to access the site and should not provide personal information in order to view the site. The Cookies do not require personal information to be used and does not identify internet users. Disabling and refusing cookies is possible from the user's browser settings.

All modern browsers offer the ability to change cookie settings.

These settings are usually found in "options" or in the "preferences" menu of the user's browser. The refusal of cookies obliges the user to close the navigation session without accessing the site, or it may continue assuming view the site in this way.

Cookies used by [www.universalsa.ro](http://www.universalsa.ro) are of two types:

- session Cookies - these are temporarily stored in the web browser's cookie folder until the user exits the website or closes the browser window and refers to the language in which is the site displayed (RO / EN);
- cookies placed by third parties - namely Google Analytics for visitor analysis.

It allows monitoring of unique users who are visiting the site and how often they do. This cookie is not used to identify individuals, they are used only for statistical purposes. Compliance of this privacy policy and data security must be completed also with the policy from Google Analytics.
